## Food/Entertainment Vendor Application

### Rules & Regulations:

1. Applications due by August 17, 2018.
2. **Set up:** Saturday, September 15 (7:00 - 9:00 a.m.).
3. All vendors are solely responsible for meeting the requirements of the State Health Department. All licenses, permits and insurance are the responsibility of the vendor.
4. The Greater Enid Chamber of Commerce can not intervene on the vendors behalf with the City of Enid, State Health Dept. or Garfield County for any variance in rules or regulations.
5. All vendors will be responsible for supplying garden hoses, catch buckets, trash bags and electrical drop cords.
6. All vendors shall make a reasonable effort to maintain their booth space as it was prior to the event.
7. **SELECTION OF FOOD VENDORS WILL BE BASED ON DATE APPLICATION IS RECEIVED AND TYPE OF FOOD ITEM SERVED.** The Cherokee Strip Celebration Committee has the right to refuse any request for sale of a specific food item or drink and will have final choice of the foods/beverages represented.
8. **10% of the gross sales of the vendor will be paid to the Greater Enid Chamber of Commerce as booth rent. Payment is due by 5:00 p.m. on Monday, September 17, 2018. You are responsible for collecting sales tax of 8.35%. If you do not have a sales tax number, a representative of the Enid Chamber will collect and remit the tax to the Oklahoma Tax Commission.**
9. The Greater Enid Chamber of Commerce and the Cherokee Strip Committee will not be responsible for any loss due to theft, accident, damage, inclement weather or other unforeseen circumstances occurring at the Cherokee Strip Celebration or the downtown Enid area.
10. Confirmation or rejection will be mailed by August 31, 2018.
